On exhausting the GCP capacity, you would be required to apply afresh to get a new GCP by paying full requisite fee as applicable at that juncture.



You may upload the same by login in to GS1 India's GEPIR website at www.gs1india.org.in. The username is [REDACTED] and Password is [REDACTED]

No other organisation (sister concern, subsidiaries, group company etc.) is permitted to use the same. Please also ensure compliance with the "Terms for use of GS1 Company prefix number" which are available at <http://www.gs1india.org/Support/GetRegistered>.

The use of the GCP is valid up to **30/06/2018**. For continued use of the same beyond this date, you would need to renew your subscription through payment of renewal fee on or before the validity date to avoid termination/cancellation of the same.
